Eligibility criteria to apply for certification/registration	Graduation from an ACGC accredited master's degree training program and verification of clinical training completion by program director.
Required criteria to apply for a Masters degree in Genetic Counseling	Varies by program but generally includes a BA degree from an accredited university; GRE exam and pre-requisites of some courses such as genetics, statistics, psychology, etc.
If there is a Masters Degree in Genetic Counseling, is this accredited? If so, by whom?	There are 35 ACGC accredited programs that are located in the United States and Canada. All ACGC accredited training program must reside in institutions that are regionally accredited by an agency recognized by the United States Department of Education or comparable provincial accreditation in Canada
Minimum length of time between completing the training requirements and applying for certification/registration	The examination is offered twice per year during the months of February and August and graduates can apply upon graduation from an accredited program. Generally, the waiting period is between application and administration is approximately 3-6 months. However individuals can apply in the month the exam is administered in a late application process. Eligible candidates have a five year window with a limited number of attempts in which to become certified following graduation.

This survey results in a <u>detailed content outline</u> and these are the areas that are tested on the examination. The national practice analysis is conducted approximately every 5 years. Additionally, the ACGC accredited program's curriculum must address the <u>Practice Based</u> <u>Competencies.</u>

There are currently 22 states that require a license to practice genetic counseling. In these states, the profession is regulated by the state board that issues licenses. In all states, the licensure applicant must be currently certified by ABGC.
What requirements exist to maintain certification/registration? How frequently is certification/registration maintained?	ABGC requires individuals to recertify every 5 years by submitting documentation of 12.5 Continuing Education Units or by taking and successfully completing the examination.
Do you have an international policy on registration of genetic counselors trained outside your country? If so, please provide a link to this	Not at this time. ABGC has engaged a taskforce to look at this issue, but at present there is no way to qualify for the examination for individuals who have not graduated from an ACGC accredited program.
